

ORDINANCE NO. 684

AN ORDINANCE OF THE CITY OF CATHEDRAL CITY
AMENDING SECTION 12.20.01 0 OF THE CATHEDRAL CITY
MUNICIPAL CODE RELATING TO THE DESIGNATION OF
SPECIAL SPEED LIMITS.

The City Council of the City of Cathedral City does hereby ordain as follows:

SECTION Ia. NEW SPEED LIMITS ADDED. Subsection (B) of 12.20.010 of the Cathedral City Municipal Code is hereby amended by the adoption of the following:

SECTION 3. Posting. The City Clerk shall within fifteen (15) days after the passage of this Ordinance, cause it to be posted in at least the 3 public places designated by resolution of the City Council; shall certify to the adoption and posting of this Ordinance; and shall cause this Ordinance and its certification, together with proof of posting, to be entered in the book of Ordinances and the Municipal Code of this City.

The foregoing was approved and adopted at a regular meeting of the City Council of the City of Cathedral City held on 10-28-2009, by the following vote:

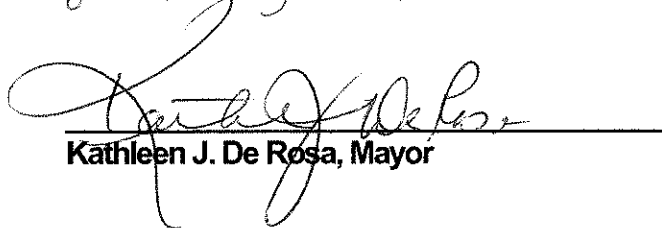

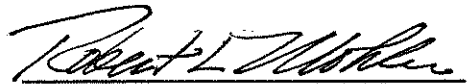

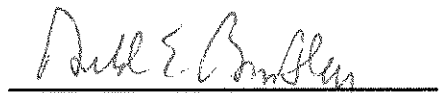
