A 4.00 FOOT WIDE STRIP OF LAND LYING WITHIN THE NORTHEAST QUARTER OF SECTION 33, TOWNSHIP 4 SOUTH, RANGE 5 EAST, SAN BERNARDINO BASE AND MERIDIAN, THE CENTERLINE OF SAID STRIP IS DESCRIBED AS FOLLOWS:

COMMENCING AT THE INTERSECTION OF THE CENTERLINE OF DATE PALM DRIVE, 40.00 FOOT HALF-WIDTH WITH THE CENTERLINE OF BUDDY ROGERS AVENUE (FORMERLY SECOND STREET), 40.00 FEET WIDE, AS SAID INTERSECTION BEING SHOWN ON RECORD OF SURVEY, AS PER MAP FILED IN BOOK 54, PAGES 13 THROUGH 15 OF RECORD OF SURVEYS, IN THE OFFICE OF SAID COUNTY RECORDER; THENCE ALONG THE CENTERLINE OF SAID BUDDY ROGERS AVENUE (FORMERLY SECOND STREET), SOUTH 89°57'26" WEST 377.00 FEET; THENCE LEAVING THE CENTERLINE OF SAID BUDDY ROGERS AVENUE (FORMERLY SECOND STREET), NORTH 00°02'34" WEST 20.00 FEET TO THE NORTHERLY LINE OF SAID BUDDY ROGERS AVENUE (FORMERLY SECOND STREET) AND THE TRUE POINT OF BEGINNING; THENCE CONTINUING NORTH 00°02'34" EAST 9.00 FEET TO A POINT OF ENDING.
