The unexpired term on the Palm Springs International Airport Commission and the Public Arts Commission will each expire on June 30, 2018.



I served there for 32 years and had a number of responsibilities including that of liaison for our Aero Squadron, a group of volunteer pilots that operated our city-owned aircraft.

As a retiree, my schedule will allow me to devote the necessary time and effort.



### RECOMMENDATION:

This item is presented for information, discussion and direction only.

### **BACKGROUND:**

The full presentation is attached for your review. At the conclusion of this presentation you will note the City's General Fund Balance or "Savings Account" has grown. We are doing better and stabilizing; however, since a disproportionate amount of our core General Fund Revenue comes from auto related sales and services, which is considered an extremely volatile industry, it is essential we continue to grow our "Savings Account" to maintain the target amount of 50% of budgeted expenditures.

For Example- "Sales Tax", "Transactions and Use Taxes" & "In Lieu Vehicle License Fees" provide a combined total \$19.2 million dollars or 52% of our General Fund Revenue. Of this, \$11.5 million or 60% is generated from auto related sales and service.

### **DISCUSSION:**

The auto industry is one of the first industries to be impacted during an economic downturn and would have a considerable impact on the City's "Savings Account" making it important to grow our General Fund Balance. For this reason, the City Council established a General Fund Balance Policy ("Savings Account") target of 50% of budgeted expenditures to achieve by 2020 to be better able to plan for such volatility.

Again, this past year we were fortunate to receive some one time monies that have moved us towards achieving this target sooner than expected. Although we have stabilized, we must manage our staff growth carefully and thoughtfully. Over the next several years we will have increased costs

to CalPERS for our pension obligations as their investment rate of return has been reduced and their planned smoothing techniques for agencies to pay their unfunded liabilities to 100% will cause our PERS obligations to more than double until the year 2031 at today's staffing levels. If there is a downturn in the economy, especially as we see the auto industry softening right now, combined with these increased operating costs will have an adverse effect on our reserves. In addition, as our OPEB obligations rise due to increased healthcare costs and the number of retirees grow, it is vital we keep a basic principal in mind and that is we must see revenue increases related to other community development growth before we expand our workforce further.



### Tax Revenue Breakdown



### General Tax Revenue Trend















# The City's Savings Account is its General Fund Balance

- City's General Fund Balance or "Savings Account" has grown.
- Revenues have stablized but auto sales have recently softened over calendar 2015
- Disproportionate amount of our core General Fund Revenue comes from auto related sales and services
- For example, "Sales Tax", "Transactions and Use Tax" & "Vehicle License Fees" provide a combined total of \$19.2 million or 52% of our General Fund Revenue. Of this, \$11.5 million or 60% is generated from auto related sales and services.
- This past year, we were fortunate to receive one-time monies totaling \$1.5 million that assisted us in achieving this target sooner than expected.
- PERS and OPEB Obligations will almost double over the next 7 years at existing staffing levels

### RECOMMENDATION:

Presentation to the City Council by Representatives of the Desert Health Care District for a Dream Homes Place Based Initiative, with an introduction by City Staff, is to generate questions, discussion and City Council direction.

### **BACKGROUND:**

The City is currently emphasizing its investment in the Dream Homes area located east of Gene Autry Drive and north of Ramon. The investment includes the recent completion of a sidewalk infill project, the just completed crack sealing all of the Dream Homes area's streets to be followed by a Project to apply Rubberized Emulsion Aggregate Slurry (REAS) to all the streets starting this November. In addition, the City has designated three City properties in the area to be developed into a community park/community center, has held a public meeting to discuss ideas for these properties and has authorized the funding of a grant consultant to assist staff in finding funding for these facilities.

City Staff and its consultant have had discussions with the Desert Health Care District (DHCD) regarding the proposed community park/community center. Out of these discussions, DHC proposed that the needs of the area may be bigger than just a community park and is proposing that the City and DHCD that DHCD work with the Dream Homes Community with a more holistic approach. DHCD has had several successes with Place Based Initiatives, recently one in an area of Desert Hot Springs and the other in an area in north Palm Springs. DHCD is now looking at the Dream Homes area as an ideal location to initiate a place based initiative. DHCD Staff has already received approval for this Place Based Initiative from their Board.

What is a place based initiative? This can be explained better by quoting the Center for the Study of Policy as follows:

"Research and experience shows that families do better when they live in strong and supportive

communities. In short, place matters. ... An equitable approach to ensuring that all the neighborhoods become the kinds of places that enable all children and families to succeed and thrive requires intentional efforts to build, sustain and operationalize certain types of community capacity.

This capacity is a combination of knowledge, skills, relationships, interactions and organizational resources that enable residents, civic leaders, the public and private sectors and local organizations to transform neighborhoods into places of opportunity. Based on our experience working with communities, we believe the following types of capacity are essential for successful and sustainable neighborhood transformation:

- Managing a broadly supported community process designed to improve results for children and families in a particular neighborhood;
- Working with neighborhood residents as leaders, "owners" and implementers of neighborhood transformation efforts;
- Creating strategic and accountable partnerships that engage multiple sectors and share accountability for results;
- Collecting, analyzing and using data for learning and accountability;
- Designing and implementing strategies based on the best available evidence of what works;
- Addressing policy and regulatory issues;
- Using sophisticated communications strategies to build public and political will;
- Deepening organizational and leadership capacity.

Increasingly, funders and federal officials are focusing their investments on place-based efforts to improve the outcome of families.

### **DISCUSSION:**

DHCD will present past examples of successes in place based efforts and the partnerships that these initiatives create. Several of DHCD past efforts have brought in partners such as Loma Linda University and the University of California at Riverside.

DHCD is proposing to create a strategic plan to create a collective impact for the Dream Homes area. One of the first tasks to be presented is the development of a community specific Health Needs Assessment. This would involve the recruiting and training of community members to be hired as Community Health Workers.

DHCD Staff will present all the above and the initial concepts to the City Council for discussion and direction.

A case study of the Desert Highlands Gateway place base initiative provided by DHCD is attached for reference.

### Desert Highland Gateway Community Placed-based Initiative: A Case Study

### The Need:

On September 28, 2011 an initial meeting between representatives of the District and Hidden Harvest, an agency which brought a bi-monthly farmer's market to the Desert Highland Gateway community (DHGC) noted that Well in the Desert, (a provider of meals to local homeless people in need) through a "Dash and Dine" program also brought food to this isolated and underserved health care community. The District also discovered that Emergency Room (ER) use by DHGC residents was disproportionately high, due to lack of knowledge of healthcare access and outreach.

An investigation began to attempt to find ways to create a placed-based initiative in the DHGC to address healthcare issues.

### The Process:

In 2012, it was learned that Loma Linda University (LLU) began conducting a Promotores Academy, as part of their Institute of Community Partnerships, in conjunction with El Sol Neighborhood Education Center (El Sol) beginning in 2011. El Sol was also preparing to expand their Promotores training of Community Health Workers (CHWs) to include African American community members. This training included, for the first time, concept design, quantitative and qualitative analysis, and evaluation by CHWs.

Meetings were held between stakeholders the District, LLU, and El Sol beginning in 2013 to initiate work in the DHGC. Later that year, Jarvis Crawford of the James O. Jesse Desert Highland Unity Center (JOJDHUC) was approached about a grant proposal to identify specific health concerns and needs of the DHGC. This grant linking DHCD, LLU, and El Sol as stakeholders was eventually discussed at meetings held at the Unity Center. Other potential stakeholders were invited to participate including pastors and other community members and leaders. The importance and benefit to the community of the grant was the topic of discussion at all of the stakeholder meetings.

The eventual hiring of 4 Community Health Workers (CHWs) came out of these early stakeholder meetings. The CHW program was created with 4 trainees from the community. These CHWs were chosen based upon community familiarity. The CHWs began conducting stakeholder meetings and eventually conducted a health needs assessment from February to June 2014, as well as follow-up interviews and focus groups. The CHWs also held a community meeting to

discuss the findings of the assessment, so the DHGC could understand the results of the activities.

The goals of the assessment were to learn key healthcare issues of the DHGC, provide recommendations to the District to lessen the health disparities in the community.

### The Results:

a. The Health Needs Assessment: The assessment consisted of 2 phases-a quantitative and qualitative study. The quantitative study consisted of a survey questioning demographics, disease measures, health behaviors, and healthcare access. The results revealed common health-related issues in the community, which were reduced to 4 priority areas to be studied in more depth. The 4 areas were healthcare affordability, healthcare access and ER use, hypertension/ high cholesterol and obesity, and health impacts of arrest and incarceration.

In the qualitative study, results revealed 40% of the community were affected by health care affordability, 33% by healthcare access, 33% by high blood pressure, high cholesterol and obesity, and 40% have health impacts due to arrest and incarceration.

b. The Desert Highland Gateway Health and Wellness Committee: The Desert Highland Gateway Health and Wellness Committee was created as a natural by-product of the work of the CHWs. The role of the newly formed Committee is to provide direction and leadership for integrating community views in all aspects of health and wellness promotion, planning, and policy, and, to work with a range of partners to prioritize and establish programs and interventions that build a healthy community and eliminate health disparities.

In April 2015, goals achieved at the end of a grant with Loma Linda University Institute of Community Partnership included that Committee will serve as the voice of the community and the decision-making body using the collective impact approach to community development centered on health. The Committee will provide the community leadership moving forward in prioritizing how to address the needs and implement the recommendations identified in the Desert Highland Gateway Community Health Assessment.

c. <u>The Strategic Plan:</u> A strategic plan was developed and accepted by the Desert Highland Gateway Health and Wellness Committee.

d. The Project: In the Spring of 2016 the District Board approved Phase 3 of the continuing project for one year (October 2016 – September 2017)– Community Capacity Development to Advance Health and Wellness through a Community-Led Strategic Plan – with a budget to implement the project. This included a staffing method through the Desert Healthcare Foundation and also a scope of work for the CHWs.

**The Goals:** The Desert Highland Gateway Community Health & Wellness Committee, along with three (3) Community Health Workers, will, in one year:

- 1. identify a possible fiscal agent and/or incorporate the Committee as a nonprofit 501 (c)(3) organization.
- 2. Engage in fund development training which would include grant writing and other procedures.
- 3. Support Committee meeting preparations, minute taking & follow up, dissemination of information to the community.
- 4. Develop Action Plans for a minimum of 3 of the 5 Priority Issues from the Committee's strategic plan.
- 5. Implement the Desert Highland Gateway Community Health & Wellness Committee's 3 Action Plans
- 6. Engage in Promotore 101 Training.
- 7. Engage faith-based community involvement through health education events or other outreach strategies.
- 8. Develop funding requests as needed to support identified needs.

### **RECOMMENDATION:**

Staff will make a presentation to the City Council in order to receive comments and direction for updating Resolution No. 90-94 and the Cathedral City Municipal Code (CCMC) 8.30 "Underground Wires."

#### **BACKGROUND:**

In 1990 the City Council adopted Resolution No.90-94 which adopted the Master Underground Program (MUP) and established a fee to fund the implementation of the MUP pursuant to Cathedral City Municipal Code (CCMC) 8.30 "Underground Wires."

The MUP created a building fee of \$0.15 per square foot of total floor area of all new construction and also created a priority schedule to further the City's electrical utility undergrounding effort.

Title 8 Chapter 8.30 Section 8.30.060 of the CCMC provides that "The city shall prepare and amend, from time to time, a Master Undergrounding Plan (M.U.P.) which shall show all community lines and Regional Transmission Lines which require undergrounding."

### **DISCUSSION:**

The City has had a number of development submittal inquiries which involve parcels that have power pole(s) within and/or abutting the parcel. Most of the parcels in question are considered "infill projects" that are generally smaller than larger master planned projects.

City Staff, in its review of these development applications with respect to the MUP, are finding that the MUP needs to be updated with regard to several issues, and not limited to the following discussion points:

- The fee for funding the MUP is based on costs that are outdated and have since risen significantly.

- The practicality of undergrounding specific overhead utilities within the MUP outlined corridors.
- The ability to underground overhead utilities' "under burden" on specific overhead utilities.
- Participation in undergrounding of specific overhead utilities.
- Rule 20A funds

Staff will also present investigation results of what neighboring Cities require with regard to undergrounding.

### Cathedral City Municipal Code Title 8 BUILDINGS AND CONSTRUCTION

### **Chapter 8.30 UNDERGROUND WIRES**

### 8.30.010 Declaration of cause.

The city council finds that the preservation and protection of the health, safety and general welfare of the residents of this city, and the public at large, require that poles, wires and associated structures, known as utility structures as defined herein, shall not be constructed, placed and installed above the surface of the ground wherever underground construction is feasible, for the following reasons:

- (a) Utility poles, wires and associated structures could be a danger to fire suppression personnel and street maintenance personnel, who, by reason of their jobs and duties, may come in close proximity thereto, particularly when using ladders, booms, and cranes. The construction, placement and installation of such wires and associated structures underground will substantially reduce said hazards.
- (b) The location of utility structures above the ground surface makes them susceptible to damage, destruction, and being rendered inoperable by weather or human causation. This may result in services provided thereby to be interrupted, the uninterrupted continuation of which is vitally needed for the protection of the public health, safety and general welfare, particularly life-saving institutions such as hospitals and fire and law enforcement communication facilities. The construction, placement and installation of said wires and associated structures underground reduces the chances of such interruption.
- (c) The existence of utility structures above the ground is detrimental to the general welfare of the city by its blight on the natural beauty and aesthetic environment of the city, and the resulting interference with the restfulness, tranquility and pleasure of city residents in viewing the natural landscape of the city. The underground installation, placement and construction of wires and associated structures will enhance and preserve the natural beauty and landscape of the city by keeping from public view such functional but nonaesthetic facilities. (Ord. 286 § 3, 1990)

#### **8.30.020 Definitions.**

- (a) "Utility structure" means all poles, wires and associated structures that provide electric, telephone, communication, and cable television service to users, customers, and subscribers.
- (b) "Service" means the electric current, tele- phone signals and cable television transmission that are generated, produced, carried, and provided by the utility companies for the use and benefit of their customers and subscribers.
- (c) "Service lines" mean the utility conductors that extend from the local line to the building, structure, or improvement which consumes or uses the service.
- (d) "Local line" means the utility system that supplies service to the service lines, and is located on public utility easements or on easements granted directly to the utility company upon privately-owned property which are adjacent to or coincident upon the rear or interior side

property lines. Local lines that carry electric service are normally energized at less than thirty-five thousand volts.

(e) "Community line" means the utility system that supplies service to the local lines or in some instances to the service lines. Community lines are within public rights-of-way or in easements adjacent to or within the public rights-of-way. In some instances they are affixed to regional transmission

line structures. Community lines that provide electric service are energized at less than 35,000 volts.

(f) "Regional Transmission Line" means the utility systems that supply electric service to community lines and local lines and are energized at 35,000 volts or greater. The structures supporting regional transmission lines may in some instances carry local and community lines as well. (Ord. 286 § 3, 1990)

### **8.30.030** Obligation.

The owner or developer proposing a construction project has the obligation to comply with all the requirements of this chapter, and in performance of said obligation shall make the necessary arrangements with the appropriate utilities for the installation and construction of utility facilities so that they will be in compliance with the provisions of this chapter. This shall be accomplished prior to issuance of building permits of the construction project. (Ord. 286 § 3, 1990)

### 8.30.040 Undergrounding of new facilities.

Except as otherwise provided in this chapter, all new service wires, local lines and community lines shall be constructed underground. (Ord. 286 § 3, 1990)

### 8.30.050 Undergrounding of existing facilities.

Except as otherwise provided in this chapter, the following existing utility structures shall be undergrounded at time of property development.

- (a) Service lines.
- (b) Local lines, where a length of two hundred feet or more of the facility is located totally within the boundary of the development project.
- (c) Community lines, where a length of six hundred feet or more of the facility is located along the same side of the street of the development project.

Note: For the purpose of this Section, development shall mean the construction of any new main building or the reconstruction of or additions to existing buildings where the valuation of the new construction is greater than 50% of the replacement value of the existing structure. Further, all phase development that occurred within the previous 5 years shall be counted in the valuation of the reconstruction or additions. (Ord. 286 § 3, 1990)

### 8.30.060 Underground fees.

The city shall prepare and amend, from time to time, a Master Undergrounding Plan (M.U.P.) which shall show all community lines and Regional Transmission Lines which require undergrounding. The M.U.P. shall designate logical underground construction increments or phases, which shall be prioritized by location and importance. The M.U.P. shall be reviewed and approved annually by the City Council. For the purpose of defraying the cost of undergrounding

the lines designated in the M.U.P., a fee shall be imposed upon all permits for new construction and development. This fee shall be adopted by City Council Resolution and shall meet the following:

- (a) The fee amount shall approximate the cost of undergrounding all lines designated in the M.U.P. within the city within a reasonable period of time, in proportion to the individual project's impact and the relative number of projects which may reasonably be expected to contribute to such total cost.
- (b) Where the development project is required to underground existing community or regional transmission lines as a condition of development approval, credit shall be given to the developer for actual costs incurred in undergrounding such regional or community transmission lines as a deduction from the underground fee otherwise due. If the undergrounding costs equal or exceed the fee, no fee shall be required. However, a reimbursement contract shall be executed between the city and the developer for any additional cost for off-site undergrounding of existing lines contained in the M.U.P. if such undergrounding is a condition of approval. The funds for reimbursement shall be taken only from the Master Undergrounding Trust Fund established herein. The reimbursement shall be made within five years of occupancy of the site. If the reimbursement is not completed within five years due to insufficient funds within the Trust Fund, the reimbursement obligation shall be null and void.
- (c) The fee shall not be waived for projects that are required to underground new utility structures.
- (d) Money collected through these fees shall be held in a designated master undergrounding trust fund and shall be spent only on community or regional transmission lines undergrounding projects within the city, but may be spent anywhere within the city regardless of where in the city they are collected.
- (e) Prior to the time of budget adoption, the City Council shall review the fee amount to determine if the anticipated revenue therefrom is deemed sufficient to accomplish the undergrounding projects as designated in the M.U.P., and approved by the City Council, within a reasonable period.
- (f) By adoption of an amending Resolution, the City Council may adjust the fee accordingly to assure full undergrounding of the projects as designated in the M.U.P. in a reasonable period of time.
- (g) The fee shall be collected prior to the issuance of building permits, and shall be placed into a fund for the purposes specified herein. (Ord. 306 § 2, 1990; Ord. 286 § 3, 1990)

### 8.30.070 Underground projects.

The City Council shall consider the inclusion of an underground project(s) in the annual capital improvement budget. The annual budget may omit underground projects provided that a finding is made that insufficient funds exist to fund a project of reasonable magnitude and size, or that a desired underground project requires more funds than can be accumulated in the budget year. However, in no case shall the city not approve an underground project, as designated in the M.U.P, within any 5-year period. In addition to the fee specified herein, funding for underground projects may be obtained from funds distributed to the city per Rule 20A (Allocation for Underground Conversion Funds), the State of California, or other funds or sources the City Council or Redevelopment Agency may designate. (Ord. 286 § 3, 1990)

At the time of formation of an underground project, the City Council may also consider the creation of an Underground Utility District, as provided in Chapter 14.28 of this code, that would logically be an extension of the underground project. The Underground Utility District would be formed for the primary purpose of undergrounding service wires and local lines. However, it could encompass all utility structures, including regional transmission lines. If the city determines that a logical Utility Underground District could be created, the City Council shall direct the preparation of appropriate maps showing all lines that could logically be undergrounded as part of the underground project, and carry forth the proceedings and public hearing per Chapter 14.28. (Ord. 286 § 3, 1990)

#### **8.30.090** Exceptions.

The provisions of this chapter shall not apply to the following utilities structures under the circumstances as hereinafter described:

- (a) Regional transmission lines upon specific exception by the City Council.
- (b) Utility structures proposed for the sole purpose of terminating overhead utility structures.
- (c) Surface-mounted transformers, pedestal-mounted terminal boxes, meter cabinets, concealed ducts, and other appurtenances and associated equipment which are part of and necessary for the operation of underground service.
- (d) Utility service installed by a utility company for temporary purposes, including, but not limited to, servicing building construction projects. No "temporary" service shall be provided for more than 180 days for residential and 360 days for non-residential at any one project site without specific approval of the City Council.
- (e) Communication, radio or television antennae, transmitters, receivers, masts, dishes, or other facilities which by their nature must be located above ground, or which are regulated or controlled elsewhere in the Municipal Code. (Ord. 286 § 3, 1990)

#### 8.30.100 Appeals.

If any person believes that the application of any provision of this chapter is impractical and will cause practical difficulties and unnecessary hardship to that person, or the public in general, due to undue costs, unusual topographical conditions, irregular street or lot configurations, design constraints of the project or utility structure, underground obstacles, or other natural conditions which would make the underground installation of utility facilities unreasonable or impractical, said person may apply in writing to the city council for a waiver of such provision of this article. Said application shall be filed with the city clerk, who shall schedule the matter for city council consideration no later than thirty days thereafter. The city council may grant a waiver from any or all provisions of this article after considering the application therefor and after making a finding that the application of the specific provision in question would be unreasonable, impractical and cause undue hardship to the applicant or the general public. If the city council does grant a waiver, it may impose reasonable conditions on said grant in the interests of protecting and preserving the public health, safety and general welfare, which may, but need not necessarily, include imposition or an "in lieu" fee to be deposited in the master undergrounding fund. The city council shall make its decision on the application no later than thirty days after it has concluded its consideration thereof. The decision of the city council shall be final. (Ord. 286 § 3, 1990)

#### RESOLUTION NO. 90- 94

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF CATHEDRAL CITY, COUNTY OF RIVERSIDE, CALIFORNIA ADOPTING THE MASTER UNDERGROUND PLAN (M.U.P.) AND ESTABLISHING A FEE TO FUND THE IMPLEMENTATION OF THE M.U.P., PURSUANT TO CHAPTER 8.30, UNDERGROUND UTILITIES, OF THE CATHEDRAL CITY MUNICIPAL CODE.

WHEREAS, the City Council has carefully reviewed the findings made at the time of adoption of Chapter 8.30 of the Cathedral City Municipal Code, and following the presentation of further evidence herein finds that such findings remain valid and current, the City Council determines that the findings contained in Section 8.30.010, Declaration of Cause, of the Cathedral City Municipal Code are proper reasons to adopt the Master Underground Plan, hereinafter sometimes referred to as the "M.U.P.," and to implement the imposition of the development fees necessary to carry out the Plan; and

WHEREAS, the City Council finds that Section 8.30.060, Underground Fees, of the Cathedral City Municipal Code requires that the City prepare an M.U.P. and adopt a fee to be imposed upon all permits for new construction and development; and

WHEREAS, subsection (a) of Section 8.30.060 requires that the fee amount shall approximate the cost of undergrounding all lines designated in the M.U.P. within the city within a reasonable period of time, in proportion to the individual project's impact and the relative number of projects which may reasonably be expected to contribute to such total cost; and

WHEREAS, all requirements of Cathedral City Municipal Code Chapter 8.30, Underground Wires, including exceptions thereof, collection of fees, and disbursement of funds, shall be met; and

WHEREAS, the City Council for the City of Cathedral City has considered the matter at its regularly scheduled meeting of October 3, 1990; and

WHEREAS, the City Council has reviewed the information submitted relative to compliance with the California Environmental Quality Act, and is satisfied from all proofs received that the project is categorically exempt;

NOW THEREFORE, the City Council of the City of Cathedral City does hereby find and determine as follows:

The City Council does hereby find that there SECTION 1. is a reasonable relationship between the fee's use and the type of development project on which the fee is imposed because all uses in the city, be it residential or non-residential, will gain by the improved living environment of the undergrounding of existing overhead utilities. Property values are increased and safety hazards are removed. Further, the City Council has found that the existence of utility structures above the ground is detrimental to the general welfare of the city by its blight on the natural beauty environment of the aesthetic city, and the resulting interference with the restfulness, tranquility and pleasure of city residents in viewing the natural landscape of the city. underground installation, placement and construction of wires and associated structures will enhance and preserve the natural beauty and landscape of the city by keeping from public view such functional but nonaesthetic facilities.

SECTION 2. The City Council does hereby find that there is a reasonable relationship between the need for the public to wit: utility undergrounding, and the type of development project on which the fee is imposed because all new development in the city benefits from undergrounding the existing utilities throughout the city because the environment, property values, and public safety are all enhanced The City Council has found that the location of utility structures above the ground surface makes them susceptible to damage, destruction, and being rendered inoperable by weather or human causation. This may result in services provided thereby to be interrupted, the uninterrupted continuation of which is vitally needed for the protection of the public health, safety and general welfare, particularly life-saving institutions such as hospitals and fire and law enforcement communication facilities. construction, placement and installation of said wires associated structures underground reduces the chances of such interruption. Further, utility poles, wires and associated structures could be a danger to fire suppression personnel and street maintenance personnel, who, by reason of their jobs and duties, may come in close proximity thereto, particularly when using ladders, booms, and cranes. The construction, placement and installation of such wires and associated structures underground will substantially reduce said hazards.

- SECTION 3. The City Council does hereby find that there is a reasonable relationship between the amount of the fee and the cost of the public facility, or portion of the public facility, attributable to the development on which the fee is imposed. This is assured by spreading the project over a 30-year period, thus spreading the costs through time. Further, since most of the ultimate development of the city will be built in this time period, the costs will be reasonably divided. Finally, a portion of the undergrounding costs will be provided by existing development through Redevelopment tax increments, General Fund sources and Community Service charges, as well as through utility company funding made available through regulatory proceedings from proceeds realized from existing utility customers.
- SECTION 4. Based on the staff report, the findings set forth in this resolution, evidence presented at the hearing, and the City Council's review of the entire record of proceedings, the City Council does hereby adopt its Master Underground Plan, dated August 30, 1990, attached hereto as Exhibit A and incorporated herein by this reference, and, further, does hereby establish the underground utility fee as \$0.15 per square foot of total floor area (excluding garages, carports, patios and other ancillary structures in residential uses) of all new construction. is to be paid to the City prior to issuance of construction permit except where deferral is specifically mandated upon the city by state law, in which event full compliance with state law relative to security for and payment of such fee shall apply. All such fees shall be placed in a fund especially designated for underground projects as approved by the City Council. The fee shall be in place until all overhead lines as listed in the M.U.P. are underground, or 30 years from the date of adoption, whichever comes first, unless modified to meet changing future conditions.
- SECTION 5. All funds received as a result of the imposition of this fee shall be deposited, invested, accounted for and expended pursuant to Government Code Section 66006 and Cathedral City Municipal Code Chapter 8.30. Any protests shall be filed and processed in accordance with the procedures specified in Government Code Sections 66008 and 66009.
- SECTION 6. The City Council does hereby determine this project to be categorically exempt under the provisions of the California Environmental Quality Act, and hereby authorizes city staff to file the appropriate documents evidencing such determination.
