RE: Appeal of the issuance of conditional use permit NO. 16-023 to West Coast Cannabis Club (medical cannabis dispensary). City Council Agenda item 3D.

Dear City Council Members,

My name is Kenneth Churchill and I am the President and Co-Founder of WCCC (West Coast Cannabis Club.) As you are aware, we received approval from the planning commission on 10/19/2016 to open and operate a medical cannabis dispensary. I am aware that there will be an appeal hearing on 12/14/2016, and would like an opportunity to address the appeal letter than was sent by Mr. Michael Petersen of 10/27/2016.

After reading the letter sent by Mr. Petersen, I couldn't help but notice that his overall concern did not appear to be our application in particular. Instead, its focus was on what he believes to be a problem with the cities definition on "Undue Concentration." I believe the City has made their definition of undue concentration undoubtedly clear and has even added a Moratorium on future dispensary applications. For these reasons, I find the appeal of our application to be an egregious waste of the City Council's time and I question Mr. Petersen's motives in the first place.

A small amount of research on Mr. Petersen will not only show that he is not a resident of Cathedral City, and that he has been involved in a *substantial* amount of small claims court cases in Riverside County over the last few years, but also that he has close ties to (and is possibly related to) an individual named Julie Montante, the owner of a medical cannabis dispensary less than 5 miles away in Palm Springs. Not only are the two of them named as co-plaintiffs in multiple court cases, but they own a home together at 41765 Largo, Palm Desert, Ca 92211. Julie herself applied for a Cannabis Permit in Cathedral City in 2014. I do not intend to turn this appeal hearing into a personal attack on Mr. Petersen, but I do ask the City Council to take his past and his relationship with Ms. Montante into consideration. Please see the number of resources I have attached concerning their relationship for more information.

As far as undue concentration is concerned, I believe the city has already established precedence here and has already taken the proper steps by adding a moratorium on future applications. Mr. Petersen's appeal centers on having two dispensaries within 300 feet of each other. As you know, Vista Chino already has two dispensaries approved and operating. These two businesses are in the same building and are a literal 10 feet from each other. The Perez Corridor also has several dispensaries within a half mile area. The precedence the city has already set in its application process shows that we are actually the LEAST concentrated portion of the city.

I understand that not everyone in this industry is an upstanding citizen who has the local community in mind. I assure you that I however, take our reputation very seriously. We have never lied about anything on our application, we have followed every rule and regulation that the city has provided for us, we have NEVER operated an illegal dispensary and we are willing to do anything the community asks of us. Above all else, we have already received approval from the planning commission in a 4-1 vote. We ask that the city council give us the opportunity to prove what the planning commission has already decided we deserve. Given the chance to prove ourselves, I am confident that the city council and the Cathedral City community will be proud of the establishment we operate.

Hello Tracey,

AB 1787 goes into effect on January 1 and revises the Brown Act to provide that if a local agency has time limits on public comments then the agency must allow a person who utilizes a translator to have at least double the amount of time "to ensure that non-English speakers receive the same opportunity to directly address the legislative body of a local agency." The only exception to this new rule is if the agency utilizes "simultaneous translation equipment in a manner that allows the legislative body of a local agency to hear the translated public testimony simultaneously." Since, to my knowledge, Cathedral City does not have simultaneous translation equipment, starting in January we will need to ensure that anyone who utilizes a translator is given at least 6 minutes to speak. We should ensure that the agenda is updated to reflect this change in law. I am not sure if the current 3 minute time limit on comments is embodied in a formally adopted policy or resolution. If so, then the City should also make sure the appropriate amendments are made to such policy or resolution.
