#### Overview

Cathedral City has been my home for four years – previously in Palm Springs for six – and I have developed a lot of energy, creativity, and enthusiasm to help create the environments described in this proposal. The goal is to get <u>your</u> enthusiasm. Cathedral City lies between two dynamic, destination cities in the Valley; Palm Springs and Rancho Mirage. With no shopping center and little beyond a movie theater the magnets are weak to draw in residents or people from across the Valley. As a member of the Parks and Recreation Commission, I can effectively research how to create destination attractions for our city. This proposal can be a foundation from which to move forward; with your enthusiasm.

#### The 2005 Master Plan

The 2005 Master Plan states that people come to parks for sports and for family gatherings. However, the Plan said that many families go to other city's parks for their children to play on sports teams. To research why that happens is part of this proposal. The Senior Center was also discussed in the Plan and it seems to be rather standard and perhaps underutilized.

#### Senior Centers or Destination Centers

What if a Senior Center became a destination center? Consider the activities they currently have. How well are they attended? Is the Senior Center attracting the baby boomers? As a baby boomer, I don't think of myself as a Senior Citizen and the Senior Center is not the first place I would think of to go. *Maybe a new name for the Senior Center would be a start.* Then research/survey baby boomers to determine their enthusiasm for various activities, programs, and classes. Does someone have a talent or skill that they would like to share; e.g., teach a photo-taking-sharing class, including editing? Jam sessions in the Senior Center and in our parks.

#### Cathedral City Parks as Destination Centers

We can make Cathedral City's parks dynamic. In this Valley, **an indoor park**, would be a destination for all/many of its residents, those who experience a lot of way-less-fun-to-be-outsidedays. Different areas for different age groups or activities, a section for dogs, an indoor walking track, and more.

Our outdoor parks can be enhanced with biking and walking trails and fitness areas for yoga, aerobics, and other outdoor classes. The Master Plan states that restrooms were dirty and in poor condition. As essential as <u>all cleanliness</u> – but this in particular – is to any park's success, it becomes a critical element when the goal is a destination park.

Another innovative idea comes from Tokyo, Japan. The Japanese have a park with playground equipment designed around and built with recycled tires. Tires would get hot in the summer. For our Valley, a water tube system to keep them cool could be part of the design. What about **tree houses** – fun for adults and kids – built with safety the number one consideration and second, a unique and fun experience...from picnics to studying outdoors.

In the future, we can make a branded, marketing statement to the Valley that Cathedral City's parks and its Senior/NewName Center have become destination centers.
