Notice is hereby given that the Cathedral City City Council will hold a Public Hearing on the following:

PROPOSAL

A recommendation to the City Council that the Council amend the North City Specific Plan (NCSP) and the North City Extended Specific Plan (NCESP) to allow cannabis businesses in the Mixed Use - Urban (MU-U) and Business Park (BP) zones in the NCSP area, and in the MU-U, Light Industrial (I-1) and Mixed Use - Neighborhood (MU-N) zones of the NCESP area. The amendments would also reduce the gross floor area that must be devoted to commercial uses on parcels 10 acres or larger in the MU-U zone to 10% of the gross floor area of the project.

ENVIRONMENTAL DETERMINATION

An EIR was certified for the NCSP in 2009, which was also relied upon for the approval of the NCESP. In accordance with CEQA Guideline 15162, no additional CEQA review is required for this specific plan amendment as there is no substantial evidence in the record that this amendment would require "major revisions" to the EIR "due to the involvement of new significant environmental effects or a substantial increase in the severity of previously identified significant effects."
